Open Issues

Members were asked via email if a current member of the HOA, who is now selling her home, could retain Meyer, Capel as her legal team since there has been a conflict with her in the past concerning her HOA dues.

The board members voted to release Meyer, Capel to represent the homeowner. At this time the HOA has no further issue with this homeowner.

1707 Grand Ave is in foreclosure. Recovering dues is usually too difficult in a foreclosure situation. We could file a lein on the property, paying for recording fees, etc.
